### NOTE BY THE TECHNICAL SECRETARIAT

#### STATUS OF SUBMISSION OF ANNUAL DECLARATIONS REGARDING ANTICIPATED ACTIVITIES AT SCHEDULE 2 AND 3 PLANT SITES IN 2025

1. Paragraph 8 of Article VI of the Chemical Weapons Convention (the Convention) states that “[e]ach State Party shall make annual declarations regarding the relevant chemicals and facilities in accordance with the Verification Annex”.
2. Part VII of the Verification Annex to the Convention covers the regime for Schedule 2 chemicals and facilities related to them. According to subparagraph 4(c) of that Part, each State Party shall submit annual declarations on anticipated activities “not later than 60 days before the beginning of the following calendar year”.
3. Subparagraph 4(c) of Part VIII of the Verification Annex requires the same of each State Party for plant sites producing Schedule 3 chemicals.
4. The deadline for the submission of these declarations for 2025 was thus 1 November 2024. The States Parties listed in the Table below met that deadline.
5. In addition, a number of States Parties submitted “nil” declarations on anticipated activities at Schedule 2 and 3 plant sites by the deadline, informing the Technical Secretariat that they anticipate no declarable activities in this regard. All these States Parties are also listed in the Table below and are denoted with an asterisk (\*).
